Adopts the Rules of the House of Representatives for the 111th Congress as the Rules for the 112th Congress, with amendments.

- **Jan 5, 2011:** Ms. Norton moved to refer the resolution to a select committee of five members, to be appointed by the Speaker, not more than three of whom shall be from the same political party, with instructions to report back the same until it has conducted a full and complete study of, and made a determination on, the constitutionality of the provision that would be eliminated from the Rules that granted voting rights in the Committee of the Whole to the Delegates.
- **Jan 5, 2011:** Mr. Cantor moved to table the motion to refer (consideration: CR H10-11)
- **Jan 5, 2011:** On motion to table the motion to refer Agreed to by the Yeas and Nays: 223 - 188 (Roll no. 3). (consideration: CR H10-11)
