- **Mar 7, 2012:** DEBATE - The House resumed debate on H. Res. 572.
- **Mar 7, 2012:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 572, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.

- **Mar 7, 2012:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 6, 2012:** Introduced in House
- **Mar 6, 2012:** The House Committee on Rules reported an original measure, H. Rept. 112-409, by Mr. Sessions.
- **Mar 6, 2012:** The resolution provides that an amendment in the nature of a substitute consisting of text of Rules Committee Print 112-17 shall be considered as adopted. The resolution waives all points of order against the amendments printed in the report.
- **Mar 6, 2012:** Placed on the House Calendar, Calendar No. 117.
