Department of State, Foreign Operations, and Related Programs Appropriations Act, 2013 - Makes FY2013 appropriations for the Department of State (Department) for:

- administration of foreign affairs and diplomatic and consular programs;
- the Capital Investment Fund;
- the Office of Inspector General;
- educational and cultural exchange programs;
- representation allowances;
- protection of foreign missions and officials;
- U.S. embassy security, construction, and maintenance;
- emergencies in the diplomatic and consular service;
- the repatriation loans program account;
- the American Institute in Taiwan;
- the Foreign Service Retirement and Disability Fund;
- international organizations, peacekeeping, and commissions;
- the International Boundary and Water Commission, United States and Mexico;
- salaries and expenses;
- plan preparation and construction of authorized projects;
- the International Joint Commission, the International Boundary Commission, United States and Canada, and the Border Environment Cooperation Commission;
- international fisheries commissions;
- international broadcasting operations and capital improvements;
- the Asia Foundation;
- the United States Institute for Peace;
- the Center for Middle Eastern-Western Dialogue Trust Fund;
- the Eisenhower Exchange Fellowships, Incorporated;
- the Israeli Arab Scholarship Program;
- the National Endowment for Democracy;
- the Commission for Preservation of America's Heritage Abroad;
- the United States Commission on International Religious Freedom;

- the Export-Import Bank of the United States, including the Office of Inspector General, direct and guaranteed loans, tied-aid grants, insurance programs, and administrative expenses;
- the Overseas Private Investment Corporation (OPIC) credit and insurance programs, including administrative expenses, and for the cost of direct and guaranteed loans; and
- the Trade and Development Agency.

Sets forth limitations on callable capital subscriptions with respect to:

- the International Bank for Reconstruction and Development;
- the Inter-American Development Bank;
- the Asian Development Bank; and
- the African Development Bank.

Sets forth certain limits and prohibitions on the use of appropriations for specified activities.
