FISA Amendments Act Reauthorization Act of 2012 - Amends the FISA Amendments Act of 2008 to extend until December 31, 2017: (1) the date for repeal of title VII of the Foreign Intelligence Surveillance Act of 1978 (procedures concerning the electronic surveillance of certain persons outside the United States for foreign intelligence information purposes); and (2) any order, authorization, or directive issued or made under that title.

- **Sep 12, 2012:** Resolution provides for consideration of both H.R. 5544 and H.R. 5949. Both measures are debatable for one hour each. For H.R. 5544, specified amendments are in order. For H.R. 5949, the amendment in the nature of a substitute recommended by the Committee on the Judiciary now printed in the bill, shall be considered as adopted. For each bill, one motion to recommit is in order, with or without instructions.
- **Sep 12, 2012:** DEBATE - The House proceeded with one hour of debate on H.R. 5949.
- **Sep 12, 2012:** The previous question was ordered pursuant to the rule. (consideration: CR H5900)
- **Sep 12, 2012:** POSTPONED PROCEEDINGS - The Chair put the question on adoption of H.R. 5949, and announced that the ayes had prevailed. Mr. Ruppersberger demanded the yeas and nays, and the Chair postponed further proceedings on question of adoption until later in the legislative day.
