### Summary (as of Jun 29, 2012)

---

Permits the chief executive of a state to exempt persons in the state acting in their capacity as farmers from a requirement of a covered federal environmental law by determining that such requirement is unduly burdensome to such persons.

Requires the chief executive to solicit and accept public comments for at least 90 days before finalizing any such determination.

Defines "covered federal environmental law" to mean the Clean Air Act insofar as it applies to emissions of air pollutants other than those resulting from the combustion of fossil fuel, the Federal Water Pollution Control Act (commonly known as the Clean Water Act), and the Solid Waste Disposal Act.

### Actions Timeline

---

- **Jul 2, 2012:** Referred to the Subcommittee on Water Resources and Environment.
- **Jun 29, 2012:** Introduced in House
- **Jun 29, 2012:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 29, 2012:** Referred to the Subcommittee on Energy and Power.
