### Summary (as of Aug 1, 2012)

Wildfire Suppression Aircraft Transfer Act of 2012 - Directs the Secretary of Defense (DOD) to transfer to the Secretary of Agriculture (USDA) 14 C-27J aircraft that are excess to DOD needs and that acceptable for use by the Forest Service for wildfire suppression purposes. Grants the USDA Secretary priority over other federal agencies regarding such transfers.

Allows the DOD Secretary during FY2013-FY2017 to sell aircraft and aircraft parts that are excess to DOD needs to persons or entities contracting with the federal government for wildfire suppression purposes.

### Actions Timeline

- **Sep 13, 2012:** Referred to the Subcommittee on Readiness.
- **Sep 11, 2012:** Referred to the Subcommittee on Conservation, Energy, and Forestry.
- **Aug 1, 2012:** Introduced in House
- **Aug 1, 2012:** Referred to the Committee on Armed Services, and in addition to the Committees on Agriculture, and Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
