Streamlining Claims Processing for Federal Contractor Employees Act - Transfers authority from the Government Accountability Office (GAO) to the Department of Labor for processing claims for wages due to laborers and mechanics hired by contractors on public works projects.

- **Nov 13, 2012:** Mr. Walberg moved to suspend the rules and pass the bill.

- **Nov 13, 2012:** DEBATE - The House proceeded with forty minutes of debate on H.R. 6371.
- **Nov 13, 2012:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
