## Summary (as of May 17, 2012)

Recognizes school boards as deliberative public bodies that should be free to engage in prayer at the beginning of meetings consistent with the prayer practice upheld in *Marsh v. Chambers*.

Expresses support for the voluntary practice of prayer at the beginning of meetings of legislative bodies and other deliberative public bodies, including school board meetings.

## Actions Timeline

- **Jun 4, 2012:** Referred to the Subcommittee on the Constitution.
- **May 17, 2012:** Introduced in House
- **May 17, 2012:** Referred to the Committee on Education and the Workforce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
