### Summary (as of Feb 11, 2011)

Save Our States Act - Delays the effective date of the Patient Protection and Affordable Care Act and the health care provisions of the Health Care and Education Reconciliation Act of 2010, and prohibits the federal government from promulgating any further regulations or otherwise preparing to implement the the provisions of such Acts, until the U.S. Supreme Court renders a judgment that includes a holding on the constitutionality of the requirement to maintain minimum essential coverage in any case pending before a federal court on the date of the enactment of this Act.

### Actions Timeline

- **Mar 4, 2011:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Feb 28, 2011:** Referred to the Subcommittee on the Constitution.
- **Feb 18, 2011:** Referred to the Subcommittee on Health.
- **Feb 17, 2011:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **Feb 11, 2011:** Introduced in House
- **Feb 11, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, Natural Resources, the Judiciary, Rules, Appropriations, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
