## Summary (as of Jan 1, 2013)

Congressional Pay Freeze and Fiscal Responsibility Act - Amends the Continuing Appropriations Act, 2011, as amended by the Continuing Appropriations Resolution, 2013 (P.L. 112-175), to extend the freeze on adjustments to pay of federal employees and officials, including Members of Congress, through December 31, 2013.

Eliminates the delayed statutory pay adjustment contained in the Resolution that was permitted to take effect with the first applicable pay period beginning after March 27, 2013.

## Actions Timeline

- **Jan 2, 2013:** Received in the Senate and Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
- **Jan 1, 2013:** Introduced in House
- **Jan 1, 2013:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 1, 2013:** Mr. Issa moved to suspend the rules and pass the bill.
- **Jan 1, 2013:** Considered under suspension of the rules. (consideration: CR H7521-7527)
- **Jan 1, 2013:** DEBATE - The House proceeded with forty minutes of debate on H.R. 6726.
- **Jan 1, 2013:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Jan 1, 2013:** Considered as unfinished business. (consideration: CR H7529)
