Summary (as of Feb 11, 2011)

Strengthening Medicare Anti-Fraud Measures Act of 2011 - Amends title XI of the Social Security Act to authorize the Secretary of Health and Human Services (HHS) to exclude from participation in any federal health care program entities affiliated with a sanctioned entity, as well as any officer or managing employee of an affiliated entity (currently, only individuals with an ownership or control interest in a sanctioned entity), if the affiliated entity was so affiliated at the time of any of the conduct forming the basis for the conviction or exclusion of the sanctioned entity.

Actions Timeline

- **Feb 18, 2011:** Referred to the Subcommittee on Health.
- **Feb 11, 2011:** Introduced in House
- **Feb 11, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, and the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
