112 HRES 73	Procedurally related	Feb 10, 2011: Motion to reconsider laid on the table Agreed to without objection.

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Requires each of the following House Committees to inventory and review existing, pending, and proposed regulations, orders, and other administrative actions or procedures by federal agencies within its jurisdiction: (1) Agriculture, (2) Education and the Workforce, (3) Energy and Commerce, (4) Financial Services, (5) the Judiciary, (6) Natural Resources, (7) Oversight and Government Reform, (8) Small Business, (9) Transportation and Infrastructure, and (10) Ways and Means.

Requires each committee, upon completion of its inventory and review, to: (1) consider specified matters, (2) conduct any hearings and other oversight activities necessary in support of the inventory and review, and (3) identify in a report on the first session of the 112th Congress any oversight or legislative activity conducted in support of, or as a result of, such inventory and review.

Actions Timeline

- **Feb 11, 2011:** Considered as unfinished business. (consideration: CR H686-714)
- **Feb 11, 2011:** DEBATE - The Chair announced that when consideration of H.Res. 72 was postponed on Thursday, February 10, 2011, 4 hours of debate remained on the resolution, with 3 hours equally divided and controlled by the chairs and ranking minority members of the Committees on the Judiciary, Agriculture, and Oversight and Government Reform, and 1 hour equally divided and controlled by the chair and ranking minority member of the Committee on Education and the Workforce and the Majority and Minority Leader or their designees.
- **Feb 11, 2011:** The previous question was ordered pursuant to the rule. (consideration: CR H713)
- **Feb 11, 2011:** Mr. Carnahan moved to recommit with instructions to Rules. (consideration: CR H713; text: CR H713)
- **Feb 11, 2011:** The instructions contained in the motion seek to require the resolution to be reported back to the House forthwith with an amendment adding a new section directing committees to place a high priority on preserving the standards that ensure the safety of the Nation's food supply, safe drinking water, and the safety of children's toys.
- **Feb 11, 2011:** The previous question on the motion to recommit with instructions was ordered without objection. (consideration: CR H713)
- **Feb 11, 2011:** On motion to recommit with instructions Failed by the Yeas and Nays: 178 - 242 (Roll no. 32). (consideration: CR H713)
- **Feb 11, 2011:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 391 - 28 (Roll no. 33).

The resolution provides that the amendment recommended by the Committee on Rules now printed in H. Res. 72 shall be considered as adopted.
