Summary (as of Jul 13, 2012)

Expresses: (1) disapproval of the fact that our U.S. Olympic uniforms were made overseas, and (2) support for U.S. manufacturers and their ability to compete in the global marketplace in both price and quality.

Urges the U.S. Olympic Committee to pledge to use American designers and manufacturers for Olympic uniforms in the future.

Actions Timeline

- **Jul 13, 2012:** Introduced in House
- **Jul 13, 2012:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jul 13, 2012:** Referred to the Subcommittee on Commerce, Manufacturing, and Trade.
