- **Nov 13, 2012:** The House Committee on Rules reported an original measure, H. Rept. 112-693, by Mr. Dreier.
- **Nov 13, 2012:** The resolution provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 112-33 shall be considered as adopted. The resolution waives all points of order against consideration of the bill.
- **Nov 13, 2012:** Placed on the House Calendar, Calendar No. 164.
