Summary (as of Feb 18, 2011)

Government Shutdown Fairness Act - Prohibits Members of Congress and the President from receiving basic pay for any period in which: (1) there is more than a 24-hour lapse in appropriations for any federal agency or department as a result of a failure to enact a regular appropriations bill or continuing resolution, or (2) the federal government is unable to make payments or meet obligations because the public debt limit has been reached.

Actions Timeline

- Aug 20, 2012: Referred to the Subcommittee on Federal Workforce, U.S. Postal Service, and Labor Policy.
- Feb 18, 2011: Introduced in House
- Feb 18, 2011: Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
