Makes it in order at any time through the legislative day of December 28, 2012, for the Speaker of the House of Representatives to entertain motions that the House suspend the rules.

Actions Timeline

- **Dec 12, 2012:** Considered as privileged matter. (consideration: CR H6714-6723)
- **Dec 12, 2012:** DEBATE - The House proceeded with one hour of debate on H. Res. 827.
- **Dec 12, 2012:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 827, the Chair put the question on ordering the previous question, and by voice vote announced that the ayes had prevailed. Ms. Slaughter demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Dec 12, 2012:** Considered as unfinished business. (consideration: CR H6739-6740)
- **Dec 12, 2012:** On ordering the previous question Agreed to by the Yeas and Nays: 224 - 183 (Roll no. 621). (consideration: CR H6722-6723, H6739-6740; text: CR H6722-6723)
- **Dec 12, 2012:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 226 - 178 (Roll no. 622).(text: CR H6714)
- **Dec 12, 2012:** On agreeing to the resolution Agreed to by the Yeas and Nays: 226 - 178 (Roll no. 622). (text: CR H6714)
- **Dec 12, 2012:** Motion to reconsider laid on the table Agreed to without objection.
- **Dec 11, 2012:** Introduced in House
- **Dec 11, 2012:** The resolution provides that it shall be in order at any time through the legislative day of December 28, 2012, for the Speaker to entertain motions that the House suspend the rules as though under clause 1 of rule XV.
- **Dec 11, 2012:** The House Committee on Rules reported an original measure, H. Rept. 112-700, by Mr. Sessions.
