## Summary (as of Mar 10, 2011)

Medicare Prescription Drug Savings and Choice Act of 2011 - Amends part D (Voluntary Prescription Drug Benefit Program) of title XVIII (Medicare) of the Social Security Act to provide for: (1) establishment of one or more Medicare operated prescription drug plan options; and (2) an appeals process for denials of benefits under a Medicare operated prescription drug plan.

## Actions Timeline

- **Mar 15, 2011:** Referred to the Subcommittee on Health.
- **Mar 14, 2011:** Referred to the Subcommittee on Health.
- **Mar 10, 2011:** Introduced in House
- **Mar 10, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
