Summary (as of Mar 6, 2013)

Defund Obamacare Act - Deauthorizes appropriations to carry out the Patient Protection and Affordable Care Act or the Health Care and Education Reconciliation Act of 2010, or any amendments made by them.

Rescinds the unobligated balance of funds made available under such Acts.

- **Mar 8, 2013:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **Mar 6, 2013:** Introduced in House
- **Mar 6, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, the Judiciary, Natural Resources, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
