- **Jul 25, 2014:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Con.Res. 105, the Chair put the question on the adoption of the resolution, as amended, and by voice vote, announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings on the question on adoption of the resolution, as amended, until later in the legislative day.

- **Jul 23, 2014:** ORDER OF BUSINESS - Mr. Nugent asked unanimous consent that it be in order at any time to consider H.Con.Res. 105 in the House, if called up by the Chair of the Committee on Foreign Affairs or his designee; that the amendment printed in the portion of the Congressional Record designated for that purpose in clause 8 of rule XVIII and numbered 1 be considered as adopted; that the concurrent resolution, as amended, be considered as read; and that the previous question be considered as ordered on the concurrent resolution, as amended, to adoption without intervening motion or demand for division of the question except one hour of debate equally divided and controlled by Mr. Royce of California and Mr. McGovern of Massachusetts or their respective designees. Agreed to without objection. (consideration: CR H6695)
