Summary (as of Mar 12, 2013)

Sets forth the rule for consideration of the bill (H.R. 890) to prohibit waivers relating to compliance with the work requirements for the program of block grants to States for temporary assistance for needy families.

Actions Timeline

- **Mar 13, 2013:** Considered as privileged matter. (consideration: CR H1365-1371)
- **Mar 13, 2013:** DEBATE - The House proceeded with one hour of debate on H. Res. 107.
- **Mar 13, 2013:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 107, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Cole demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H.Res. 107 until later in the legislative day.
- **Mar 13, 2013:** Considered as unfinished business. (consideration: CR H1371-1372)
- **Mar 13, 2013:** On ordering the previous question Agreed to by the Yeas and Nays: 233 - 195 (Roll no. 64). (consideration: CR H1372)
- **Mar 13, 2013:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 233 - 194 (Roll no. 65). (text: CR H1365)
- **Mar 13, 2013:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 13, 2013:** On agreeing to the resolution Agreed to by recorded vote: 233 - 194 (Roll no. 65). (text: CR H1365)
- **Mar 12, 2013:** Introduced in House
- **Mar 12, 2013:** The House Committee on Rules reported an original measure, H. Rept. 113-15, by Mr. Cole.
- **Mar 12, 2013:** All points of order against consideration of the bill are waived. An amendment in the nature of a substitute consisting of the text of Rules Committee Print 113-3 shall be considered as adopted. All points of order against provisions in the bill, as amended, are waived.
- **Mar 12, 2013:** Placed on the House Calendar, Calendar No. 7.
