## Summary (as of Mar 12, 2013)

Military Tribunals for Terrorists Act of 2013 - Requires trial only by a military commission for any foreign national who: (1) engages or has engaged in an offense relating to a terrorist attack against persons or property in the United States or U.S. government property or personnel outside the United States, and (2) is subject to trial for that offense by a military commission under the Uniform Code of Military Justice.

- **Apr 8, 2013:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, And Investigations.
- **Mar 12, 2013:** Introduced in House
- **Mar 12, 2013:** Referred to the Committee on Armed Services, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
