## Summary (as of Mar 18, 2013)

Prohibits the federal government from using a drone (unmanned aircraft) to kill a U.S. citizen located in the United States.

Makes such prohibition inapplicable to an individual who poses an immediate threat of death or serious bodily injury to another.

States that nothing in this Act shall be construed to allow the killing of a U.S. citizen located in the United States without due process of law.

## Actions Timeline

- **Apr 15, 2013:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, And Investigations.
- **Mar 18, 2013:** Introduced in House
- **Mar 18, 2013:** Referred to the Committee on Intelligence (Permanent Select), and in addition to the Committees on the Judiciary, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
