Summary (as of Mar 21, 2013)

Health Information Technology Reform Act - Amends titles XVIII (Medicare) and XIX (Medicaid) of the Social Security Act to exclude pathologists from Medicare and Medicaid incentive payments and, in particular, penalties relating to the meaningful use of electronic health records.

Actions Timeline

- **Apr 9, 2013:** Referred to the Subcommittee on Health.
- **Mar 22, 2013:** Referred to the Subcommittee on Health.
- **Mar 21, 2013:** Introduced in House
- **Mar 21, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
