### Summary (as of Apr 9, 2013)

SelectUSA Authorization Act of 2013 - Authorizes appropriations for FY2014-FY2018 for the SelectUSA Initiative (federal assistance aimed at increasing both foreign and domestic investment in U.S. business).

Directs the Secretary of Commerce to report to Congress during such fiscal years on Initiative activities.

- **Apr 9, 2013:** Introduced in House
- **Apr 9, 2013:** Referred to the House Committee on Energy and Commerce.
