Making Investments Now for Dementia Act of 2013 - Authorizes the Secretary of the Treasury to issue bonds to aid in the funding of Alzheimer's research.

Authorizes appropriations to the Director of the National Institutes of Health (NIH) for such research.

Expresses the sense of Congress that any funds collected pursuant to this Act are in addition to yearly appropriated funds and are not to be used to supplement current funding.

Actions Timeline

- **Apr 19, 2013:** Referred to the Subcommittee on Health.
- **Apr 18, 2013:** Introduced in House
- **Apr 18, 2013:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
