Summary (as of Apr 24, 2013)

Cutting Costly Codes Act of 2013 - Prohibits the Secretary of Health and Human Services (HHS) from implementing, administering, or enforcing specified regulations insofar as they would replace International Classification of Diseases (ICD)-9 with ICD-10 as a standard for code sets for appropriate data elements for financial and administrative transactions involving the electronic exchange of health information.

(The ICD is a health care classification system of diagnostic codes for classifying diseases.)

Actions Timeline

- **Jun 3, 2013:** Referred to the Subcommittee on Health.
- **Apr 26, 2013:** Referred to the Subcommittee on Health.
- **Apr 24, 2013:** Introduced in House
- **Apr 24, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
