## Summary (as of Apr 25, 2013)

In It All Together Act - Amends the Patient Protection and Affordable Care Act to limit the health plans that the federal government may make available to the President, the Vice President, and executive cabinet officials to those created under the Act or offered through an Exchange established under the Act.

- **Apr 26, 2013:** Referred to the Subcommittee on Health.

- **Apr 25, 2013:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
