Summary (as of Apr 26, 2013)

Amends the Patient Protection and Affordable Care Act (PPACA) to restrict the health plans that the federal government may make available to the President, Vice-President, or federal employees to a health plan either created under PPACA or offered through a health care exchange established under PPACA. (Currently, such restriction applies to Members of Congress and congressional staff.)

Actions Timeline

- **May 3, 2013:** Referred to the Subcommittee on Health.
- **Apr 26, 2013:** Introduced in House
- **Apr 26, 2013:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committees on Energy and Commerce, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
