## Summary (as of May 3, 2013)

No Monuments to Me Act of 2013 - Prohibits the use of federal funds for any real property, project, or program named for an individual then serving as a Member of Congress (including a Delegate or Resident Commissioner) or as President. Excepts: (1) any presidential library; or (2) any project or program commenced, or any real property named, prior to the enactment of this Act.

## Actions Timeline

- **May 6, 2013:** Referred to the Subcommittee on Economic Development, Public Buildings and Emergency Management.
- **May 3, 2013:** Introduced in House
- **May 3, 2013:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
