Summary (as of May 8, 2013)

Safety Net Abuse Prevention (SNAP) Act of 2013 - Amends the Food and Nutrition Act of 2008 to prohibit the Department of Agriculture (USDA) from using funds for any agreement with a foreign government to promote enrollment in the supplemental nutrition assistance program (SNAP, formerly known as the food stamp program).

Terminates the Partnership for Nutrition Assistance Initiative between the United States and Mexico.

Actions Timeline

- **May 22, 2013:** Referred to the Subcommittee on Department Operations, Oversight, and Nutrition.
- **May 8, 2013:** Introduced in House
- **May 8, 2013:** Referred to the Committee on Agriculture, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
