Summary (as of May 15, 2013)

Medicare Secondary Payer and Workers' Compensation Settlement Agreements Act of 2013 - Amends title XVIII (Medicare) of the Social Security Act to: (1) create an exception to Medicare secondary payer requirements for certain workers' compensation settlement agreements, and (2) provide for the satisfaction of such requirements through use of qualified Medicare set-asides under such agreements.

Actions Timeline

- **Jun 3, 2013:** Referred to the Subcommittee on Health.
- **May 17, 2013:** Referred to the Subcommittee on Health.
- **May 15, 2013:** Introduced in House
- **May 15, 2013:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
