Summary (as of Dec 11, 2013)

Israel QME Enhancement Act - Directs the President, on a biennial basis, to: (1) carry out an assessment of the extent to which Israel possesses a qualitative military edge over military threats to it, and (2) submit a related report to Congress. (Current law requires an assessment on an ongoing basis and a report every four years.)

Directs the Secretary of State to report to Congress on: (1) the range of cyber and asymmetric threats posed to Israel by state and non-state actors, and (2) joint U.S.-Israel efforts to address such threats.

- **Dec 12, 2013:** Received in the Senate and Read twice and referred to the Committee on Foreign Relations.
- **Dec 11, 2013:** Mr. Royce moved to suspend the rules and pass the bill, as amended.
- **Dec 11, 2013:** Considered under suspension of the rules. (consideration: CR H7650-7653)
- **Dec 11, 2013:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1992.
- **Dec 11, 2013:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
