**(This measure has not been amended since it was introduced. The summary of that version is repeated here.)**

Keep the IRS Off Your Health Care Act of 2013 - Prohibits the Secretary of the Treasury, or any delegate of the Secretary, from implementing or enforcing any provisions of or amendments made by the Patient Protection and Affordable Care Act or the Health Care and Education Reconciliation Act of 2010.

- **Aug 2, 2013:** Considered under the provisions of rule H. Res. 322. (consideration: CR H5362-5374)
- **Aug 2, 2013:** In each case the rule provides for one hour of debate on the bill and one motion to recommit for each bill.
- **Aug 2, 2013:** DEBATE - The House proceeded with one hour of debate on H.R. 2009.
- **Aug 2, 2013:** The previous question was ordered pursuant to the rule. (consideration: CR H5371)
- **Aug 2, 2013:** Mr. Nolan moved to recommit with instructions to Ways and Means. (consideration: CR H5371-5373; text: CR H5371)
- **Aug 2, 2013:** DEBATE - The House proceeded with 10 minutes of debate on the Nolan motion to recommit with instructions, pending the reservation of a point of order. Subsequently, the reservation was withdrawn. The instructions contained in the motion seek to require the bill to be reported back to the House forthwith with an amendment to prohibit the bill from altering, impacting, delaying or weakening section 1401 of the Patient Protection and Affordable Care Act which provides tax credits to middle class families to purchase health insurance or section 1421 of the Patient Protection and Affordable Care Act which provides tax credits to small businesses for the purchase of health insurance coverage for employees.

- **Aug 2, 2013:** Passed/agreed to in House: On passage Passed by recorded vote: 232 - 185 (Roll no. 447).(text: CR H5362)
