Summary (as of May 22, 2013)

Pay As You Rate Act - Directs the Secretary of Veterans Affairs (VA), prior to adjudicating a claim which requires decisions with respect to two or more disabilities, to make interim payments based on any disability for which the Secretary has already made a decision.

Requires the Secretary, upon claim adjudication, to pay the benefits awarded less the amount of the interim payments.
