## Summary (as of May 23, 2013)

No IRS Implementation of Obamacare Act - Prohibits the Secretary of the Treasury, or any delegate of the Secretary, from implementing or enforcing any provisions of or amendments made by the Patient Protection and Affordable Care Act or the Health Care and Education Reconciliation Act of 2010 (other than subtitle A of title II, concerning higher education funding and student loans).

Prohibits the use of taxpayer funds to implement or enforce such provisions.

- **Jun 3, 2013:** Referred to the Subcommittee on Health.
- **Jun 3, 2013:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **May 24, 2013:** Referred to the Subcommittee on Health.
- **May 23, 2013:** Introduced in House
- **May 23, 2013:** Referred to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, Education and the Workforce, the Judiciary, Natural Resources, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
