## Summary (as of Jun 14, 2013)

IRS Verification Act - Directs the Inspector General for Tax Administration of the Department of the Treasury to audit the Internal Revenue Service (IRS) in accordance with audit criteria in the Inspector General Act of 1978 for the period beginning on January 1, 2010, and ending on the enactment of this Act.

Prohibits the obligation or expenditure of any amounts to carry out the Patient Protection and Affordable Care Act until the report of the IRS audit is submitted to Congress.

- **Jun 14, 2013:** Referred to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, Education and the Workforce, the Judiciary, Natural Resources, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
