Stop Targeting Our Politics IRS Act or the STOP IRS Act - Amends the Internal Revenue Service Restructuring and Reform Act of 1998 to expand existing grounds for termination of the employment of an Internal Revenue Service (IRS) employee to include performing, delaying, or failing to perform (or threatening to perform, delay, or fail to perform) any official action (including any audit) with respect to a taxpayer for purpose of extracting personal gain or benefit or for a political purpose.

Actions Timeline

- **Aug 1, 2013:** Received in the Senate and Read twice and referred to the Committee on Finance.
- **Jul 31, 2013:** Mr. Renacci moved to suspend the rules and pass the bill.
- **Jul 31, 2013:** Considered under suspension of the rules. (consideration: CR H5212-5214)
- **Jul 31, 2013:** DEBATE - The House proceeded with forty minutes of debate on H.R. 2565.
- **Jul 31, 2013:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H5212)
- **Jul 31, 2013:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H5212)
- **Jul 31, 2013:** Motion to reconsider laid on the table Agreed to without objection.
