Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2014 - Department of Transportation Appropriations Act, 2014 - Makes appropriations for FY2014 to the Department of Transportation (DOT).

Department of Housing and Urban Development Appropriations Act, 2014 - Makes appropriations for FY2014 to the Department of Housing and Urban Development (HUD).

Makes appropriations for FY2014 to: (1) the Access Board, (2) the Federal Maritime Commission (FMC), (3) the Office of Inspector General for the National Railroad Passenger Corporation (Amtrak), (4) the National Transportation Safety Board (NTSB), (5) the Neighborhood Reinvestment Corporation, and (6) the U.S. Interagency Council on Homelessness.

Specifies certain uses and limits on or prohibitions against the use of funds appropriated by this Act.

Actions Timeline

- **Jul 30, 2013:** The resolution provides for consideration of H.R. 2397, under a structured rule, and consideration of H.R. 2610, under an open rule. The resolution provides for one hour of general debate on both bills. Additionally, the resolution provides for one motion to recommit with or without instructions for both bills.
- **Jul 30, 2013:** The Speaker designated the Honorable Luke Messer to act as Chairman of the Committee.
- **Jul 30, 2013:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 312 and Rule XVIII.
