Summary (as of Jul 10, 2013)

Emergency Information Improvement Act of 2013 - Amends the Robert T. Stafford Disaster Relief and Emergency Assistance Act to include public broadcasting facilities within the definition of a "private nonprofit facility" that provides essential services of a governmental nature to the general public, and to include broadcast and telecommunications within the definition of "critical services" provided by such a facility, for purposes of eligibility for certain disaster assistance.

Makes this Act applicable to a major disaster declared by the President under such Act on or after October 28, 2012.
