Sets forth the rule for consideration of the bill (H.R. 1947) to provide for the reform and continuation of agricultural and other programs of the Department of Agriculture through fiscal year 2018, and for other purposes; and providing for consideration of the bill (H.R. 1797) to amend title 18, United States Code, to protect pain-capable unborn children in the District of Columbia.

Actions Timeline

- **Jun 18, 2013:** By the direction of the Committee on Rules, Ms. Foxx called up H.Res. 266 and asked for its immediate consideration. (consideration: CR H3708-3710)
- **Jun 18, 2013:** POINT OF ORDER - Ms. Edwards raised a point of order against the provisions of H. Res. 266 on the grounds that it violated the Congressional Budget Act. The Chair announced that the necessary threshold had been met and the House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration of the resolution.
- **Jun 18, 2013:** On question of consideration of the resolution Agreed to by voice vote. (consideration: CR H3710)
- **Jun 18, 2013:** Considered as privileged matter. (consideration: CR H3710-3720)
- **Jun 18, 2013:** DEBATE - The House proceeded with one hour of debate on H. Res. 266.
- **Jun 18, 2013:** On ordering the previous question Agreed to by the Yeas and Nays: 229 - 196 (Roll no. 248). (consideration: CR H3719-3720)
