## Actions Timeline

---

- **Jun 19, 2013:** The House Committee on Rules reported an original measure, H. Rept. 113-117, by Mr. Sessions.
- **Jun 19, 2013:** Resolution provides for consideration of amendments to H.R. 1947
- **Jun 19, 2013:** Placed on the House Calendar, Calendar No. 34.
- **Jun 19, 2013:** By the direction of the Committee on Rules, Mr. Sessions called up H. Res. 271 and asked for its immediate consideration. (consideration: CR H3770-3774)
- **Jun 19, 2013:** POINT OF ORDER - Mr. McGovern raised a point of order against the provisions of H. Res. 271 on the grounds that it violated the Congressional Budget Act. The Chair announced that the necessary threshold had been met and the House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration of the resolution.
- **Jun 19, 2013:** On question of consideration Agreed to by voice vote. (consideration: CR S3774)
- **Jun 19, 2013:** Considered as privileged matter. (consideration: CR H3774-3786)
- **Jun 19, 2013:** DEBATE - The House proceeded with one hour of debate on H. Res. 271.
- **Jun 19, 2013:** On ordering the previous question Agreed to by the Yeas and Nays: 233 - 187 (Roll no. 253). (consideration: CR H3785-3786)
- **Jun 19, 2013:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 239 - 177 (Roll no. 254).(text: CR H3770)
- **Jun 19, 2013:** Motion to reconsider laid on the table Agreed to without objection.
