Summary (as of Jul 24, 2013)

Delays for one year the effective date of any provisions of the Patient Protection and Affordable Care Act or of any health care provisions of the Health Care and Education Reconciliation Act of 2011 that were scheduled to take effect on or after January 1, 2014.

Suspends for one year, beginning January 1, 2014, any tax or tax increase imposed by such provisions if the tax or increase takes effect before that date.

Actions Timeline

- **Jul 31, 2013:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **Jul 26, 2013:** Referred to the Subcommittee on Health.
- **Jul 24, 2013:** Introduced in House
- **Jul 24, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, the Judiciary, Natural Resources, Rules, House Administration, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
