Directs the Secretary of Agriculture (USDA) to revise the Agricultural Marketing Service Master Solicitation and Supplement specifications for the purchase of canned tuna to require that: (1) all such tuna be landed by U.S.-flagged fishing vessels; (2) not less than 75% of the value of such tuna be produced in the United States; and (3) all such tuna be canned in the United States, including Puerto Rico, the Northern Mariana Islands, or U.S. territories or possessions.

Actions Timeline

- **Aug 13, 2013:** Referred to the Subcommittee on Department Operations, Oversight, and Nutrition.
- **Jul 25, 2013:** Introduced in House
- **Jul 25, 2013:** Referred to the Committee on Agriculture, and in addition to the Committee on Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
