Deficit Reduction and Economic Growth Working Group Act of 2013 - Establishes the Bicameral Working Group on Deficit Reduction and Economic Growth, comprised of 20 Members of Congress, to recommend to the House of Representatives and Senate overall levels of discretionary spending, including for FY2014, changes in the statutory limit on the public debt, and reforms in direct spending programs.

Directs the Speaker of the House of Representatives and the Majority Leader of the Senate to each appoint 10 members of their respective chamber to serve on the Working Group. Designates a co-chair in each chamber and allows the Minority Leaders of the House and Senate to each recommend the appointment of 4 of the 10 members in each chamber.

Requires the Working Group to report its recommendations, including any required legislative language, to the House and Senate within three days after their adoption. Prohibits the Working Group from reporting any recommendation that does not receive the support of a majority of its members.

Requires the termination of the Working Group immediately after the transmission of its recommendations.

Actions Timeline

- **Oct 8, 2013:** Referred to the House Committee on Rules.
- **Oct 8, 2013:** Considered under the provisions of rule H. Res. 373. (consideration: CR H6389-6397)
- **Oct 8, 2013:** DEBATE - Pursuant to the provisions of H. Res. 373, the House proceeded with 40 minutes of debate on H.R. 3273.
- **Oct 8, 2013:** The previous question was ordered pursuant to the rule. (consideration: CR H6395)
- **Oct 8, 2013:** Ms. Brownley (CA) moved to recommit with instructions to Rules. (consideration: CR H6395; text: CR H6395)
- **Oct 8, 2013:** DEBATE - The House proceeded with ten minutes of debate on the Brownley motion to recommit with instructions, pending reservation of a point of order. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment to replace the underlying bill with the Senate Amendment to H.J.Res. 59, Continuing Appropriations Resolution, 2014.
- **Oct 8, 2013:** Point of order sustained against the motion to recommit with instructions.
- **Oct 8, 2013:** Mr. Sessions raised a point of order against the motion to recommit with instructions. Mr. Sessions stated that the proposed amendment contained in the motion to recommit with instructions was not germane. Sustained by the Chair.
- **Oct 8, 2013:** Ms. Brownley (CA) appealed the ruling of the chair. The question was then put on sustaining the ruling of the chair.
- **Oct 8, 2013:** Mr. Sessions moved to table the appeal of the ruling of the Chair. (consideration: CR H6396)
- **Oct 8, 2013:** On motion to table the appeal of the ruling of the Chair Agreed to by the Yeas and Nays: 227 - 194 (Roll no. 533). (consideration: CR H6396)
- **Oct 8, 2013:** Passed/agreed to in House: On passage Passed by the Yeas and Nays: 224 - 197 (Roll no. 534).(text: CR H6389)
- **Oct 8, 2013:** On passage Passed by the Yeas and Nays: 224 - 197 (Roll no. 534). (text: CR H6389)
- **Oct 8, 2013:** Motion to reconsider laid on the table Agreed to without objection.
- **Oct 8, 2013:** Pursuant to the provisions of H. Res. 373, and upon the adoption of H.J. Res. 89, the text of H.R. 3273, as passed by the House, is appended as new matter at the end of H.J. Res. 89 and the Clerk is directed to make conforming modifications in the engrossment of H.J. Res. 89.
