Summary (as of Oct 23, 2013)

Wildfire Prevention Act of 2013 - Amends the Robert T. Stafford Disaster Relief and Emergency Assistance Act to authorize the President to provide: (1) hazard mitigation assistance in any area in which fire management assistance was provided, whether or not a major disaster had been declared; and (2) fire management assistance in any area in which hazard mitigation assistance was provided.

Actions Timeline

- **Oct 24, 2013:** Referred to the Subcommittee on Economic Development, Public Buildings and Emergency Management.
- **Oct 23, 2013:** Introduced in House
- **Oct 23, 2013:** Referred to the House Committee on Transportation and Infrastructure.
