Summary (as of Jan 22, 2013)

Keystone For a Secure Tomorrow Act - Approves a specified permit regarding certain energy-related facilities and land transportation crossings on the international boundaries of the United States for the Keystone XL pipeline project. Includes within such permit the Nebraska reroute evaluated in the Final Evaluation Report issued the Nebraska Department of Environmental Quality in January 2013. Prescribes permit requirements.

Actions Timeline

- **Jan 28, 2013:** Referred to the Subcommittee on Public Lands and Environmental Regulation.
- **Jan 25, 2013:** Referred to the Subcommittee on Energy and Power.
- **Jan 23, 2013:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Jan 22, 2013:** Introduced in House
- **Jan 22, 2013:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committees on Energy and Commerce, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
