Sets forth the rule for consideration of the bill (H.R. 2775) to condition the provision of premium and cost-sharing subsidies under the Patient Protection and Affordable Care Act upon a certification that a program to verify household income and other qualifications for such subsidies is operational.

Mr. Burgess demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question on H. Res. 339 until a time to be announced.

- **Sep 11, 2013:** On ordering the previous question Agreed to by the Yeas and Nays: 227 - 196 (Roll no. 456). (consideration: CR H5491-5492)
- **Sep 11, 2013:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 195 (Roll no. 457).(text: CR H5487)
- **Sep 11, 2013:** On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 195 (Roll no. 457). (text: CR H5487)
- **Sep 11, 2013:** Motion to reconsider laid on the table Agreed to without objection.
