**(This measure has not been amended since it was reported to the House on May 20, 2014. The summary of that version is repeated here.)**

Improving Trauma Care Act of 2014 - Amends the Public Health Service Act to include in the definition of "trauma" injuries resulting from thermal, electrical, chemical, or radioactive agents, thus making burn centers eligible for trauma center grants and trauma research programs.
