Summary (as of Sep 26, 2013)

Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to consider a report from the Committee on Rules on the same day it is presented to the House with respect to any resolution reported through the legislative day of September 30, 2013, relating to measures making continuing FY2014 appropriations or to the public debt limit.

Concurs in the Senate amendment to H.R. 2642 (agricultural and other programs of the Department of Agriculture (USDA) through FY2018) with an amendment substituting the text of H.R. 2642, as passed by the House, modified by the insertion of the text of H.R. 3102, as passed by the House.

- **Sep 28, 2013:** DEBATE - The House proceeded with one hour of debate on H. Res. 361.

- **Sep 28, 2013:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 26, 2013:** Introduced in House
- **Sep 26, 2013:** The House Committee on Rules reported an original measure, H. Rept. 113-231, by Mr. Sessions.
- **Sep 26, 2013:** The resolution waives clause 6(a) of rule XIII against resolutions reported from the Rules Committee relating to: 1) A measure making continuing appropriations for fiscal year 2014. 2) A measure relating to the public debt limit. The resolution also provides that the House concurs in the Senate amendment to H.R. 2642 with an amendment consisting of the text of H.R. 2642, as passed by the House, modified by the insertion of a new title IV consisting of the text of H.R. 3102, as passed by the House.
- **Sep 26, 2013:** Placed on the House Calendar, Calendar No. 56.
