School Nutrition Fairness Act - Requires official White House meals and meals served at White House or Department of Agriculture (USDA) cafeterias to comply with the nutrition requirements for meals served under the school lunch and breakfast programs.

Defines an "official meal" as a lunch or dinner served at an official White House function and funded by annual appropriation Acts.

### **Actions Timeline**

- **Jan 7, 2014:** Referred to the Subcommittee on Department Operations, Oversight, and Nutrition.
- **Dec 10, 2013:** Introduced in House
- **Dec 10, 2013:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
